MEMBERSHIP CATEGORY	FEE
Child Full Skating Membership: Full skating members less than 18 years of age are entitled to participate in all activities of the club: testing, competitions, exhibitions, special events, and social functions. Includes Skating magazine and Bladelines subscriptions, club directory, club T-shirt* and coverage under USFS's sports accident insurance policy. Free memberships for non-testing, non-competing parents/guardians residing at the same address as the member.	\$120
Additional Family Member Skating Membership: additional competitive or testing skaters in the family, residing at the same address, may join for a reduced membership fee, includes club T-shirt*. If a parent/guardian/spouse competes and/or tests, the parent/guardian/spouse must register as a second family member.	\$60
First Year Skating Membership: Full skating membership available to those who have never been a member of the Birmingham Figure Skating Club, excluding Basic Skills Membership. Includes testing, competitions, exhibitions, special events, and social functions as well as Skating magazine and Bladelines subscriptions, club directory, club T-shirt * and coverage under USFS's sports accident insurance policy. Includes free memberships for non-testing, non-competing spouse/parents/guardians.	\$75
Adult Full Skating Membership: Full skating membership available to adults 18 years or older who test and/or compete. Includes Club Ice, testing, competitions, exhibitions, special events, and social functions as well as Skating magazine and Bladelines subscriptions, club T-shirt*, club directory, and coverage under USFS's sports accident insurance policy. Free membership for non- testing, non-competing spouse.	\$85
Collegiate membership: Full skating membership available to those who are current full time college students. Membership is good for four years or until year of graduation, whichever is less. Proof of full-time enrollment may be required. Includes testing, competitions, exhibitions, special events, and social functions as well as Skating magazine and Bladelines subscriptions, club directory, club T-shirt * and coverage under USFS's sports accident insurance policy.	\$100
Associate Membership: This membership is available to all current members of U.S. Figure Skating whose home club is other than the Birmingham Figure Skating Club. Membership includes social activities, the Bladelines newsletter, and a club directory. This membership excludes voting rights.	\$45
Social Membership: This membership is available to skaters enrolled in the PCC Basic Skills Program. Includes Bladelines subscription, special events, social activities, club directory and club T-shirt*. Social members may participate in the Bridge Program. Social Members may not test and are not members of the USFS. When competing, they will represent the Pelham Skate School and have competition forms signed by the Pelham Skate School, not the BFSC. Free membership for non-testing, non-competing parents.	\$30
Judges/Officials/Professionals Membership: This membership is open to U.S. Figure Skating judges, officials, and professional skaters/coaches. This membership includes special events, and social functions as well as Skating magazine and Bladelines subscriptions, club T-shirt*, and club directory. Members in this category may not test or compete.	\$45
Non-Skater Membership: This membership is available to non-skaters only. Membership includes special events and social functions as well as Skating magazine, Bladelines subscription and club directory.	\$40
Life Membership: This full skating membership is available at no fee to members by board appointment only.	N/C
Special Olympics Membership: This membership is available at no fee to Special Olympics skaters. Includes Club Ice, testing, competitions, exhibitions, special events, and social functions. Includes Skating magazine and Bladelines subscriptions, club directory, and coverage under USFS's sports accident insurance policy. Free membership for non-testing, non-competing spouse/parents/guardians.	N/C

BIRMINGHAM FIGURE SKATING CLUB Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement ("Agreement") (To be completed by ALL applicants)

In consideration of participating in Birmingham Figure Skating Club activities, I represent that I understand the nature of figure skating activities ("activity") and that I am qualified, in good health, and in proper physical condition to participate in such activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the activity.

I fully understand that this activity involves risk of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the activity, the conditions in which the activity takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, damages I incur as a result of my participation in the activity.

I (We) the member(s) and/or the parent(s)/guardian(s) of member children, do hereby release, waive, and covenant not to sue U.S. Figure Skating, the Birmingham Figure Skating Club, its directors, officers, sponsors, volunteers, agents, employees, staff, instructors, and trainers associated with these organizations or businesses for any and all suits, claims, demands of any kind for personal injuries, property losses, damages, or accidents that I (we) or my child may sustain while participating in these activities whether or not caused in whole or part by the negligence or other misconduct of any of the organizations or individuals mentioned above.
